

An excel sheet with the results of the Stripers Forever 2013 Annual Fishing Survey including the comments that some members made appears below. In 2013 we received a near record 1020 responses to our annual survey. 752, or 83% of the respondents, have fished for stripers for more than 10 years, and many of these people fished through both the last striped bass collapse and the recovery of the late 1980s and 1990s. This is a very experienced sample of the angling population. This year's survey has again produced a good representative sampling of sentiments from fishers all along the striper's migratory range, and as usual MA and NJ vied for the greatest contributions with 227 and 222 completed surveys respectively.

Without a reasonable doubt the fishery is continuing to decline. 78% of fishers report catching fewer fish compared to 4% reporting catching more. Also, 60% said they were catching smaller fish compared to only 18% claiming they were larger. Most of the older, larger fish from the great year classes of the 1990s and early 2000s have been removed from the population leaving us with smaller fish and many less fish from the poor year classes that have generally characterized the fishery since 2003.

We had survey results from 89 guides, which is one of our best years. Without a doubt the decline in striper fishing is hurting this valuable industry as well as the related fishing tourism and tackle businesses. The guides know how to fish their areas, though, and can usually produce the best results possible from their home waters. If you are thinking about a guided trip please check out the guides and tackle shops listed on the Stripers Forever website.

We will send this information to the press and to fishery policy makers everywhere. We hope that you will use this information personally to help us advocate for the goal of coast-wide striped bass game fish. Please share the results with your local fishing club, hometown newspaper, and elected officials that you may know.

Additional comments on striped bass management. ZERO LIMIT

Party boats going out twice a day should be stopped.

It would be nice to see more enforcement of the law and punishment and fines followed through. There are to many people being fined and no follow up. People who break the fishery laws are not honorable people. People like me and people I know believe in catch & release and practice this whenever we fish for stripers. For hire boats caught stripers are mostly always kept, and by people who don't understand what our fisheries are going though right now, the captains certainly do. The captain and mates should not be counting how many have to caught and kept. They need to start the MD DNR needs more resources to stop poaching, overfishing, and under reporting my commercial fisherman. Also, we should require barbless hooks for bait or lure fishing. I have been mashing or filing barbs off my hooks for 30 plus years with no more loss of fish than I would have had otherwise. If you can't manage a drag and a tight line you need to take up knitting. Treble hook lures should have two of the three hook bends also cut off. Planer boards allowing 25 plus lines to be trolled should be outlawed. Where is the sport in that?? You may as well drop grenades every hundred feet once you mark a school. "Fisherman" drag under sized bass through the water needlessly killing them as they hope for a larger fish to hook up. Buyout of commercial fishermen is a good idea, makes it more politically acceptable

After a disastrous week at Martha's Vineyard the spring of 2012 I skipped my annual trip for 2013, which friends said was even worse. Let's restore striped bass and the menhaden that feed them. It's not a coincidence that both have collapsed from levels 50 or 100 years ago. In the Chesapeake Bay, stripers need food. Omega Protein needs to be severely restricted or bought out just the way we would buy out the Stripers forever needs to get in the fight in every state. Especially in md. I find 75% of the fish gut hooked using cut bait and circle hooks because the y swallow the entire chunk while running off.

The ASMFC has done a disgraceful job not only on striped bass but other species. Such as Mackerel, there used to be a .Mackerel run for weeks, Now it's a few days or a week. I don't understand how MD can increase the catch quota by 15% when the fishing has so noticeably declined. This increase only benefits the commercial fishery since the recreational quota is never met. Someone needs to send a wake-up call to the MD State House.

All commercial fishing for striped bass should be suspended Until a healthy population of striped bass are found each year in a Maine rivers. Stripers

Need to get rid of Sarah peak por commercial fishing

Make limits the same a crossed the board ,for all states .

There should be more restrictions on commercial harvest of bait fish such as menhaden and Pollock to increase striper forage. These species have Make them a game fish, no take

The taking of the larger fish doesn't make any sense. A slot limit and end to commercial bass fishing would make the most sense.

I would like to see striped bass as a pure gamefish, no recreational or commercial harvest at all.

Many bass caught this year were thin; bout 1/4 had lesions I fish the Choptank River, an historical breeding and nursery area.

First year in over 15yrs I did not catch a keeper. Also I was not present when anyone else caught a keeper. Keepers we caught by friends but it was very inconsistent. I bunkered chunked in Delaware Bay and didn't get a chance to hit the beach but those reports were poor as well.

Management must be coordinated across all states in the striped bass' migratory habitat

The fishery is managed for the wrong goals. It should be managed to produce a quality fishery not to see how many can be caught.

A one year moratorium on keeping any stripers to help replenish the stock.

save the bunker, save the herring

Bass this year in my area aveaged 1.4" larger than previous 5 year average. There seems to be a serious lack of small bass 14-19" this year

I doubt that you really know how many stripers are caught by non commercial fishermen. Try to do that.

Moratorium on Bunker harvesting, and a ban on gill netting would do just as much as quotas, and should be considered in ADDITION to the quotas We must stop taking the large breeders. Slot limit (22" to 28") is needed. But I am not opposed to al catch and release for a few years. Personally i do I believe in the use of no take slot limits to protect vital year classes to the species. For example every state should have the two fish per person creel. One Schoolie and one larger size fish. However there should be a non-take slot of 28 to 36 inches.

I'm all in favor of banning commercial fishing for striped bass and making striped bass a gamefish(at least on the Atlantic Coast). I also think that we,

Stop commercials from catching striped gass and menhaden

Year Class Structures should be considered in setting annual allowable sizes for keeping. Limit changes every year if need be.

It is my opinion that the change in striper fishing is because of less bait fish. decreased numbers of bait fish is caused by the netting process. Bycatch from commercial boats should be stopped. Especially after that fiasco that happened in Maryland.

I believe that the current regulations encourage anglers to target mostly big fish

This year continues to reinforce my theory that the stocks are dwindling and the powers to be are a bunch of greedy idiots....they are a disgrace...."

Slot fish regulation works well for red drum and would work well for stripers too. This must coincide with commercial changes as well or they will simply harvest the big fish we conserve. This would require banning of all types of netting and make it a pin fishery only. Need to continue to crack It's not people who follow the rules or regulations that are the issue.
